

## RULES OF ALCI – Associazione Lavaggi Cisterne Industriali

According to the ALCI's Statute - art. 21

## 1) Minimum requirements:

The following requirements are mandatory to join our association and be an effective member:

- A valid SQAS Assessment. A valid SQAS assessment means that a new evaluation must be booked within the deadline otherwise the ECD authorization will be suspended;
- In order to carry a correct evaluation, the cleaning station must operate for at least 6 months before enrolling and carrying out the SQAS assessment.
- The answers to the following questions of SQAS Questionnaire 2022 (if applicable) must necessarily be positive (score 1):

- Eftco food Assessment if foodstuff are cleaned. For the candidates commitment to carry our the EFTCO FOOD by the first SQAS renewal. For Associates with timing to be defined;
- Waterproof flooring for the entire area of the tank cleaning station;
- A system for collecting of all the wastewater from the cleaning station must be installed;
- At least three cleaning heads on each cleaning bay declared available for tanks cleaning.
- Possibility of Hot Water production > 80°C;
- Covered cleaning bays;
- Use of an Explosimeter and oxygen meter for tank entry operations.
- The cleaning of tank for food must be done only with water that meets the requirements of EC Directive 98;
- Existence of Autorizzazione Unica Ambientale AUA and / or disposal contract with Waste Water Purifier consortium or other waste disposal. The authorization must be clearly indicated the activity "tank cleaning",or, at least, in the application for authorization request AUA;
- Compliance with all requirements included in the permit and the requirements pertaining to the protection of the environment (limitations, exceptions or anything that is contained in the permit). It may also be requested documentation showing the



purification capacity of the plant, the quantity / quality of treated wastewater, waste products, etc;

- All personnel must be in rule (Recruitment, contract or otherwise stating his regular position INAIL INPS);
- Cleaning Product list: washable, non-washable and immediate availability of its MSDS, 16 points;
- Presence of selection criteria for cleaning products;
- Tank registration system (cleaning order) before washing.

If a new member will be rejected due to lack of multiple requirements or for negative judgment of the SQAS auditor, the candidate must does another SQAS audit once remedied the non-compliance.

By periodic control, the non-conformity must be remedied within six month.

## 2) Obbligations

NON-comply with these obligations shall be sanctioned as required by the current sanction system:

- Use of ECD cleaning document. It is forbidden the use of any other cleaning certificate;
- Respect of EFTCO Rules 2;
- Print ECD only with matrix printer;
- Respect of ALCI 'Code of Conduct';
- Participating, as legal representative or appointed delegate, in the meetings organized by ALCI. A maximum of 2 (two) consecutive absences at the meetings are eligible. At the third absence the expulsion from the association will be voted, which involves, among other things, the prohibition of issuing ECDs;
- Communicate statistical data (Use of water, detergent and energy, production of waste, number of cleaning and ECD issues each year, injuries and accidents). The data will be in aggregate and anonymously, in accordance with the privacy policy;
- Send the documentation required by the board (SQAS assessment, ECD issued etc):
- Pay annual fee within 31 January each year.

## 3) Registration, annual membership fees and expenses reimbursements

Registration fee (una tantum) for new members € 2.000,00 Expenses reimbursements for visit/site inspection € 500,00 Annual fee € 1.000,00
